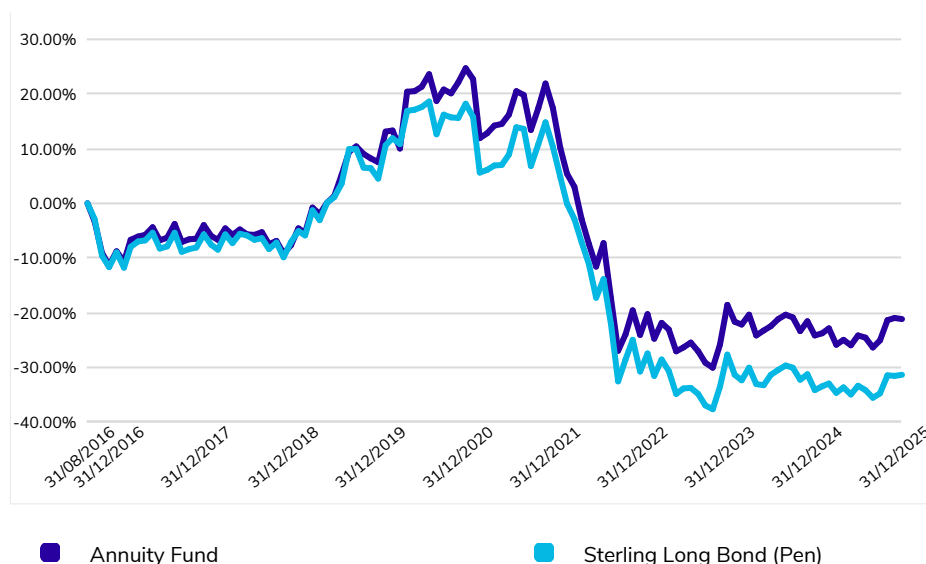

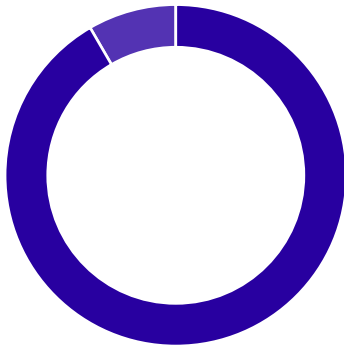

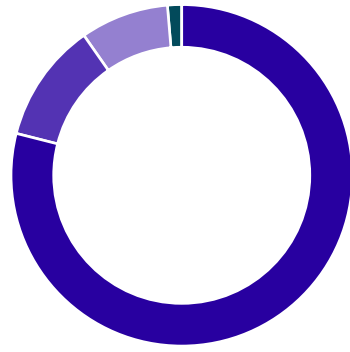
Asset allocation as at 31-12-2025

Asset Breakdown



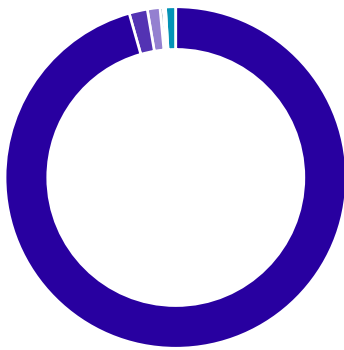
