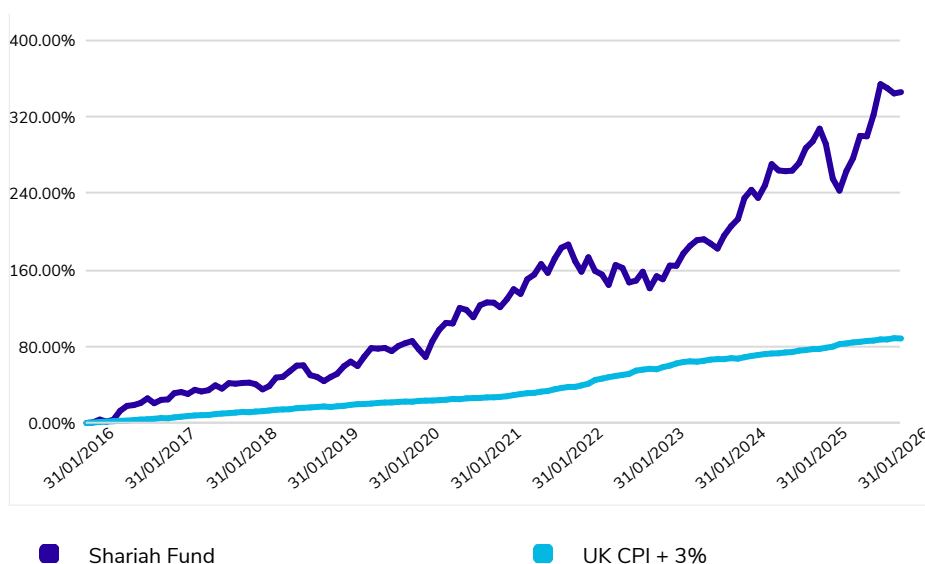

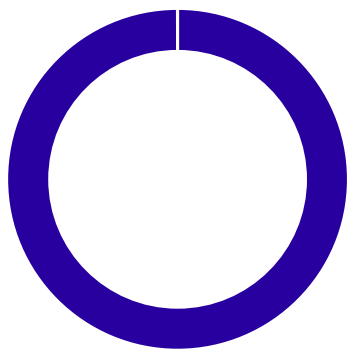

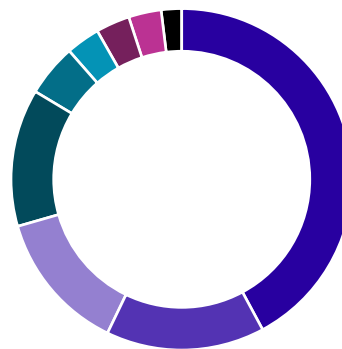
Asset allocation as at 31-01-2026

Asset Breakdown



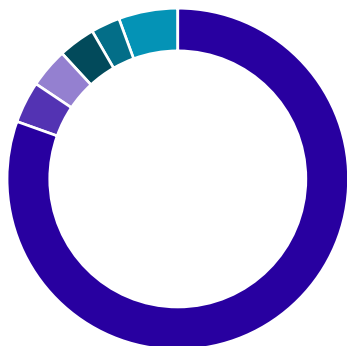
